

## CUSTOMS INFORMATION FOR TRAVELLERS



All travellers arriving on flights from non-EU countries, non-fiscal territories and travellers coming from an EU airport on a flight that originated outside the EU must make a Customs declaration by selecting the **Green** or **Red** channel.

Use the **GREEN** channel if

You have no more than the allowance to which you are entitled and you have no prohibited or restricted goods.

Use the **RED** channel if

- You are in doubt
- Have more than the entitled allowance.
- In possession of prohibited or restricted goods such as firearms, explosives, dangerous drugs, indecent or obscene material, counterfeit or pirated goods and endangered species.

Use the **BLUE** channel if

- Your last check-in was done in an EU airport.
- Your luggage tag has a green outline.

## DUTY FREE ALLOWANCE ON EXCISE GOODS

200 Cigarettes	1L Spirits Vol. exceeding 22%
100 Cigarillos	1L Undenatured Ethyl Alcohol Vol. exceeding 60%
50 Cigars	2L Liquors Vol. Not exceeding 22%
250g Smoking Tobacco	
4L Still Wine	16L Beer

**⚠️** Allocations concerning tobacco and alcohol do not apply in the case of travellers under 17 years of age.

## PERSONAL ALLOWANCE

For personal use an allowance of €430 per person is given. This allowance cannot be pooled with other passengers. Excise goods (exceeding personal allowance) need to be declared to Customs as well, whether passenger is arriving from a non EU country or not.

## CASH DECLARATIONS



Are you travelling with €10,000 or more?  
No problem. Declare them to Customs.

A declaration of cash or other monetary instruments in Euro or their equivalent in other currencies should always be submitted to Customs whether a passenger is arriving, in transit or leaving Malta, even if he/she is arriving from or departing to another EU country.

## DISEASES DON'T RESPECT BORDERS



**Did you bring your pet's papers?**  
You cannot enter the EU without the correct certification.



**If you bring in meat or dairy products from outside the EU, you risk importing animal diseases.**

If you do not declare such items, you may be fined or face criminal prosecution. These products will be seized on arrival.

You may bring in small quantities for personal consumption from the Faroe Islands and Greenland.

There are no restrictions from the EU member states and Andorra, Iceland, Northern Ireland, Liechtenstein, Norway, San Marino and Switzerland.

## PROHIBITED ITEMS



Narcotics

Smokeless tobacco  
Including but not limited to chewing, heats, snus and snuff.

Unbranded tobacco

Flavoured tobacco  
Except for personal use

Restricted Items

Protected animals • Birds / Bird skins  
Live plants & plant products • Live animals  
Counterfeit items • Arms & weapons
