Entity Presentation (We are)

We are a highly motivated team of 20 professionals made up of economists, lawyers, technical and natural scientists, working in the political spotlight on climate action. Job Presentation (We propose)

We propose a position for a highly motivated Seconded National Expert as part of our team. The post will offer a stimulating experience in one of the fast developing policy areas of DG CLIMA.

Among the tasks of the new colleague will be the following:

- Contribute to the development of certification methodologies for permanent removals, carbon farming, and long-lasting carbon storage products
- Contribute to the development of market-based approaches for climate action in the agrifood supply chain
- Contribute to the development and implementation of the climate policy framework on land use, forestry and agriculture, including the review of the LULUCF Regulation

The tasks will involve regular collaboration with other Commission services (primarily DG AGRI, ENER, ENV, JRC, RTD), the EEA, as well as contact with Member State counterparts, through working groups and seminars.

The work takes place at the crossroads of technical and financial elements, covering the whole of the EU geography and related to policies of high importance to European citizens in a rapidly evolving policy and innovation context.

Jobholder Profile (We look for)

A dynamic and pro-active candidate who has

- Strong experience in applied areas of environmental, economic, legal, social, or natural sciences, related to carbon markets, land use, agriculture, forestry, bio-economy or technological carbon removals
- A background in developing policies that will help the transition to climate neutrality
- Strong sense of collaboration with team members and with other services within the Commission
- Curiosity, adaptability, flexibility, ability to prioritise and work to deadlines, and desire to continuously learn
- Excellent oral and written communication skills in English, including the capacity to explain complex issues in a non-technical and comprehensible way
- A strong sense of initiative and very good inter-personal and networking skills
- A structured, systematic and thorough approach to work

Eligibility criteria

The secondment will be governed by the **Commission Decision C(2008) 6866** of 12/11/2008 laying down rules on the secondment to the Commission of national experts and national experts in professional training (SNE Decision).

Under the terms of the SNE Decision, you need to comply with the following eligibility criteria at **the starting date** of the secondment:

- <u>Professional experience:</u> at least three years of professional experience in administrative, legal, scientific, technical, advisory or supervisory functions which are equivalent to those of function group AD.
- <u>Seniority</u>: having worked for at least one full year (12 months) with your current employer on a permanent or contract basis.
- <u>Employer:</u> must be a national, regional or local administration or an intergovernmental public organisation (IGO); exceptionally and following a specific derogation, the Commission may accept applications where your employer is a public sector body (e.g., an agency or regulatory institute), university or independent research institute.
- <u>Linguistic skills:</u> thorough knowledge of one of the EU languages and a satisfactory knowledge of another EU language to the extent necessary for the performance of the duties. If you come from a third country, you must produce evidence of a thorough knowledge of the EU language necessary for the performance of his duties.

Conditions of secondment

During the full duration of your secondment, you must remain employed and remunerated by your employer and covered by your (national) social security system.

You shall exercise your duties within the Commission under the conditions as set out by aforementioned SNE Decision and be subject to the rules on confidentiality, loyalty and absence of conflict of interest as defined therein.

In case the position is published with allowances, these can only be granted when you fulfil the conditions provided for in Article 17 of the SNE decision.

Staff posted in a European Union Delegation are required to have a security clearance (up to SECRET UE/EU SECRET level according to <u>Commission Decision (EU, Euratom)</u> 2015/444 of 13 March 2015. It is up to you to launch the vetting procedure before getting the secondment confirmation.
